Starting as a national day of environmental recognition, Earth Day has evolved into a worldwide campaign to protect our environment. Twenty million people celebrated the first observed Earth Day on April 22, 1970. It is estimated that currently more than a half billion people worldwide participate in Earth Day celebrations. It is a time to celebrate gains we have made and create a new vision to increase environmental awareness.



Here are some ways you can celebrate Earth

Day by protecting the environment:

- Reduce consumption.
- Recycle at home and work.
- Reuse items.
- Use water wisely through Xeriscaping and water-saving devices.
- Maintain your vehicle to reduce air pollution.
- Use a mulching mower and leave your grass clippings on your lawn.
- Compost your yard trimmings and vegetable scraps.

Recycling to Keep Texas Clean and Teach Children to Preserve

Horizon Milling, LLC, Saginaw. Horizon Milling takes community outreach seriously. As a CLEAN TEXAS, CLEANER WORLD member, Horizon is committed through its employees to a number of environmental programs that ensure all children in Horizon's community have access to comprehensive and integrated environmental education.

For example, Horizon employees participate in a paper recycling program at this plant. The program teaches and motivates employees to recycle while raising funds to support the plant's partnership with Eagle Mountain-Saginaw schools. Since the project began, employees have recycled nearly 2,000 tons of paper. Employees work harder to recycle when they see that it not only saves the environment, but is also an active way to help fund education for the community's youth.

In addition, Horizon Saginaw employees visit second-through fifth-grade classrooms at a selected school to teach



students about nonpoint source pollution. Using “Wrongway City,” a watershed model/curriculum, employees explain the water cycle; the effects of pesticide and fertilizer overuse; the impact of oil and trash, clear-cutting forests, and land erosion; the loss of beneficial insects and birds; the reduction of wetlands; and more. Using relief and topographical maps, the students learn about their local environment and geography. The children, in turn, advise the Mayor of Wrongway City how to do it right.

Horizon employees also distribute Pondwater Tour kits or Watershed Tour kits to all fifth-grade classes in selected and adopted schools. The kits provide a scientific method and materials for testing nonpoint source water pollution. Through these kits, the students learn about dissolved oxygen, the nitrogen cycle, photosynthesis and pH, and the effects on water quality.
