



#### Why remove this Location and Pollutant(s) from the APWL?

Annual AutoGC benzene concentrations reported at the Texas City CAMS 620 air monitoring site in 2003 (1.09 ppb<sub>v</sub>) and 2004 (1.63 ppb<sub>v</sub>) were above the annual screening level and were of potential concern. Also, during a 2004 mobile monitoring trip, several instantaneous benzene concentrations exceeded the short- term screening level downwind of Black Marlin Pipeline Company/Williams Field Services Group LLC (100906155), with a maximum instantaneous concentration of 390 ppb<sub>v</sub>. Although these levels would not have caused short-term health effects, they would be expected to contribute to the long-term average in this area.

The 2005 (0.78 ppb<sub>v</sub>) and 2006 (0.41 ppb<sub>v</sub>) reported annual average benzene concentrations were below the long-term, health-based ESL and show a significant decrease when compared to 2004. In addition, the 2007 first quarter average benzene concentration reported at CAMS 620 (0.38 ppb<sub>v</sub>) is less than the first quarter benzene average in 2006 (0.51 ppb<sub>v</sub>) and 2005(1.46 ppb<sub>v</sub>). The Galveston County Health District completed an investigation on April 21st, 2006, and a Notice of Enforcement was issued against Black Marlin Pipeline Company/Williams Field Services Group LLC (RN100906155) that outlines strict monitoring of flare activities. It is possible that emissions reductions from this facility led to the reduction in benzene concentrations reported at CAMS 620. Overall, the TD has determined that benzene concentrations monitored at CAMS 620 are no longer a concern.
